**CATEGORIES OF INDIVIDUAL MEMBERSHIP & ELIGIBILITY CRITERIA FOR ENROLMENT**

**(A) FELLOWS**

Shall be Corporate Members of the Institute who are upgraded to Fellow Grade at the sole discretion of the IMSL Council, which will take in to consideration the Member’s commitment and participation in Institute activities, and period of service in the Council.

Fellows are entitled to use the designatory letters – **FIM(SL)**

**(B) MEMBERS**

Shall be persons elected by the Council of the Institute on the **nomination of two members**, and upon **such persons having satisfied the Council that they have been engaged in the profession of Management at Senior Executive Level** for a minimum period of **Five (5) Years**.

**OR**

Persons who possess a **post Graduate Degree/Diploma** from a recognized University or recognized Institution, in Management, Business or in any of the functional discipline/s of Management, and who satisfy the Council that they **have been engaged in the Profession of Management at Senior Executive Level for a minimum period of Two (2) years**.

Members are entitled to use the designatory letters - **MIM(SL)**

**(C) ASSOCIATE MEMBERS**

Shall be persons elected by the Council of the Institute, on the nomination of **Two (2) Members upon such** persons having satisfied the Council that they have been engaged in the **Profession of Management at Executive Level for a period of Five (5) years.**

**OR**

Persons who satisfy the Council that they have obtained Professional Qualifications from a recognized Institution, in general or in a specialized area of Management, and have been **engaged in the Profession of Management at Executive Level for a period of Two (2) years.**

Associate Members are entitled to use the designatory letters – **AMIM(SL)**

**(D) AFFILIATE MEMBERS**

Shall be persons engaged in the Profession of Management at Supervisory Level, and have the potentiality for advancement in the Profession of Management, and have the intention of obtaining Member Grade. They shall be entitled to the use of all facilities of the Institute, but they shall not be eligible to vote at any General Meeting of the IMSL, or be elected as Office Bearer(s), or Members of the Council.

**(E) STUDENT MEMBERS**

Shall be persons who have satisfied the Council that they are following a course of studies in Management at post secondary level, acceptable to the Council of the Institute, and they should have intentions of becoming Members of the Institute. They shall be entitled to the use of all facilities of the Institute, but they shall not be eligible to vote at any General Meeting of the IMSL, or be elected as Office Bearer(s), or Members of the Council.

**MEMBERSHIP FEES**

(A) Enrolment Fee (is compulsory )	: Rs. 1,000/- ( for all categories of Membership payable at the time of enrolment )
(B) Member Grade	: Rs. 3,500/- per annum
(C) Associate Member	: Rs. 2,000/- per annum
(D) Affiliate Member	: Rs. 500/- per annum
(E) Student Member	: Rs. 500/- per annum

**MEMBERSHIP LIFE**

Members and Associate members who complete five years service period in the corresponding grade and who have regularly subscribed Membership fees for a period of five years, shall qualify to seek Life Membership of the corresponding grade on payment of fees equivalent to 10 years annual subscriptions.

All payments by Credit Cards shall be made at the IMSL Secretariat. Cheques shall be drawn in favour of the **Institute of Management of Sri Lanka, and crossed “Account payee only”**.
